


MESSAGE FROM THE COMMITTEE: JUDICIAL ETHICS FOR JUVENILE COURT JUDGES

JUVENILE COURT JUDGES FACE UNIQUE ETHICAL CHALLENGES

Juvenile court judges are the linchpin of the juvenile justice system, responsible for oversight and implementation of the culture, policies, and practices that govern it. Despite their unique and interactive role, juvenile court judges are subject to the same ethical standards that apply to all judges. Neither the California Code of Judicial Ethics nor the ABA Model Code of Judicial Conduct addresses the specific ethical concerns that arise in the juvenile court landscape. As a result, juvenile court judges often find themselves navigating uncharted ethical terrain. This article and the accompanying interview discuss several common considerations faced by these judges.

Juvenile court judges have the same core duties as any judge—to fairly, promptly, and efficiently dispose of the legal issues before them. In addition, juvenile court judges are charged with protecting the well-being and safety of their communities, including individual minors, their families, and the public at large. Judges must provide for the care, treatment, and guidance of the minor while striving to preserve and strengthen family ties whenever feasible. In the juvenile justice context, judges must also ensure juveniles are held accountable for their actions. Further, juvenile court judges are charged with general oversight and "improv[ing] system performance in a vigorous and ongoing manner," and are expected to engage in efforts to improve the law, including by making recommendations regarding civil procedure and developing programs that provide assistance to children.

Judge Robert J. Trentacosta has been a member of CJEO since 2013 and serves on the executive committee. Judge Trentacosta joined the Superior Court of San Diego County in 2001, where his judicial assignments have included criminal trials, domestic violence, drug courts, and the superior court writs and appellate panels. He has also held numerous leadership positions within the court, including presiding judge. He currently presides over a department in the juvenile court.

Q: You have held many assignments on the San Diego Superior Court bench. How did you come to be in juvenile court?
